## Medicare Stakeholders Call for Copay Assistance to Part D Beneficiaries in Response to the Pressures of the Pandemic

Dear Mr. Demske:

On behalf of the undersigned organizations and over 45 million persons covered by Medicare Part D and their family caregivers, we urge you to rescind the current ban on the use of copay cards in the Medicare Part D program at least through the current Novel Coronavirus (COVID-19) pandemic. We believe this is an urgent step necessary to respond to the needs of Medicare beneficiaries during the ongoing public health emergency.

Medicare beneficiaries are struggling to pay their drug copayments now more than ever. Medicare does not limit how much patients must pay for their prescription medicines under Part D. The lack of an out-of-pocket cap is felt by Medicare beneficiaries now more than ever before, as beneficiaries and their families face the financial uncertainty caused by the COVID-19 pandemic.

We support the steps taken thus far by the HHS Office of Inspector General (OIG) in response to the unique circumstances brought on by the COVID-19 pandemic. In particular, OIG's announcement<sup>1</sup> that it will allow Federal health care program beneficiaries to use telehealth services during the outbreak will enable many Medicare beneficiaries to continue to receive necessary care from the safety of their homes. We request you to exercise similar authority to improve access for Part D beneficiaries.

We urge you to exercise the OIG's enforcement discretion and issue a policy statement announcing that, for the period of the public health emergency, penalties will not be imposed on healthcare providers and suppliers, including biopharmaceutical manufacturers, that offer patient support programs to subsidize Medicare Part D beneficiary out-of-pocket costs. Such a policy change would benefit Medicare Part D beneficiaries by facilitating access to and adherence with needed medicines. It would also improve beneficiaries' overall ability to manage critical and pressing health-related and household expenses.

During this time of great need and uncertainty, out-of-pocket cost subsidies can help to fill critical gaps and preserve access to care for millions of Medicare beneficiaries. For these reasons, we urge you to ease the current barrier to providing financial support. Thank you very much for your consideration of our request.
